## October 14, 2020 - City Council Highlights

Mayor Sturman, John Brasier, Tyrell Maughan, Johnalee McDonald, and no citizens were present. Larry Gilmore was excused.

Mayor Sturman called the meeting to order at 7:35 P.M. and led the Pledge of Allegiance.

Mayor Sturman thanked Daniel Morgan and Josh Barnes for the great job they have done on the city building

POLICE REPORT – Chief Fullmer reported 166 patrol hours; 6 overtime hours; 4 call outs; 27 traffic stops; 16 traffic citations issued; 34 incidents responded to; 2 special patrol/vacation watch; 3 animal control calls; 1 alarm; 3 traffic accidents; 2 medical calls.

FIRE REPORT – Chief Scott Norman reported 18 total members with 16 attending regular training; 104 hours training; 51 chief hours; 122 hours on actual calls (7 in Ammon - 5 wildland and 2 house fires); 1 call in Ucon; 8 total calls; 88 maintenance hours. Total: Over 1,000 hours (mostly wildland). Received \$4,000 grant for wildland gear; HEMTT had some issues while in California but they have been repaired. He informed the council that there is a grant opportunity available via the CARES Act and he would like to request eight dual-band radios for \$41,000. The council unanimously approved \$41,000 for radios via the CARES grant. *LANDSCAPE & REC REPORT – No report.* PUBLIC WORKS REPORT – Daniel Morgan reported that the new 25 HP pump and motor have been installed at Well #1 and are running well The sewer grinder has been installed and they are just waiting on brackets to be installed to finish the installation. They are getting ready to turn off and winterize sprinklers.

WATER & SEWER SYSTEM REPORT – John Brasier reported that the abnormally high sewer flow from August was due to a meter reading error. The September flow was lower than past years. BMPO REPORT – No report PLANNING & ZONING – No report. DISCUSSION – CHICKENS – Mayor Sturman stated that he had planned to discuss allowing chickens in the R1 zone; however, he had not had time to prepare anything. The issue will be discussed at the November meeting. Council meeting adjourned at 8:30 P.M.
