### City Council Highlights – January 10, 2024

Mayor Sturman, John Brasier, Tyrell Maughan, Larry Gilmore, Johnalee McDonald, and two citizens were present. Mayor Sturman called the meeting to order at 7:31 P.M. and led the Pledge of Allegiance.

MINUTES OF DECEMBER 13, 2023 – TREASURER'S REPORT, PRESENTATION OF BILLS AND TRANSFERS TO/FROM STATE POOL The council unanimously voted to approve the minutes, treasurer's report, bill payments, and treasurer's report.

OATHS OF OFFICE FOR NEWLY ELECTED COUNCIL MEMBERS – The city clerk administered the Oaths of Office and presented Certificates of Election to reelected Councilor John Brasier and newly elected Councilor Christopher Paolini.

EXCUSE EXITING COUNCIL—Mayor Sturman presented Larry Gilmore with a plaque and thanked him for his service. ELECT-COUNCIL PRESIDENT – John Brasier will continue to serve as council president.

COUNCIL DEPARTMENT ASSIGNMENTS – Christopher Paolini - Bonneville Metropolitan Planning Organization (BMPO) board / Tyrell Maughan: Parks & Rec/Arbor Day / John Brasier: Water & Sewer / Johnalee McDonald: Founders Day

POLICE REPORT – Chief Fullmer reported 296 patrol hours; 1 arrest/warrant; 72 traffic stops; 19 traffic citations issued; 2 ordinance violations; 136 calls for service. He reported that he wasn't able to participate in Shop With a Cop this year. He said that he was able to assist Ucon Fire Department on a few calls and commended them for their efforts. He requested and received approval for \$500 to purchase a small trailer and build it into a speed trailer. He is looking forward to the Cops vs Kids sled race on January 20<sup>th</sup>. He thanked the sponsors for their donations. FIRE REPORT - Chief Norman reported 20 members, 15 attending regular training, and three wildland members; 22 training hours; 62 chief hours; 231 hours on actual calls (3 – Ucon; 1 Swan Valley assist; 1 Ririe assist; 1 Ammon assist); 5 hours maintenance; 320 total hours. He thanked Ucon Police Department for assisting on calls. He is still waiting for the ISO rating. He is excited to help with the event on January 20<sup>th</sup>. He would like to enter into a mutual aid agreement with Swan Valley. He will work on the agreement and present it at the February meeting. Johnalee McDonald thanked the fire department for their hard work and remarked that she loves to see them on the news. Christopher Paolini asked about the status of the radios and Chief Norman stated that they are still working on them.

LANDSCAPE & REC REPORT – no report.

PUBLIC WORKS REPORT – Mayor Sturman reported that there are still issues with wells #1 and #3 but they should be repaired soon.

WATER & SEWER SYSTEM REPORT – John Brasier reported that the December flow was 4.1 million gallons

which is almost identical to the November flow and similar to previous years. In 2023 the flow was 49.6 million gallons at a cost of \$182,000.

PLANNING & ZONING – no report

EXECUTIVE SESSION – PERSONNEL – The council unanimously voted to adjourn into executive session at 8:19 P.M. in accordance with Idaho Code 74-206 (b) to consider the evaluation, dismissal or disciplining of, or to hear complaints or charges brought against, a public officer, employee, staff member or individual agent or public-school student. The council resumed their regular session at 8:36 P.M.

EMPLOYEE EVALUATIONS—The council unanimously approved 5% employee wage increases.. CITY COUNCIL MEETING ADJOURNED AT 8:38 P.M.
